## CIRCULAR

### 28th Delhi State Inter-School Shooting Competition 2025

25th June – 27<sup>th</sup> June 2025

02nd June 2025

To,

All School Students of Delhi / Members of DSRA

Dear Shooters,

We are pleased to inform you that the 28th Delhi State Inter-School Shooting Competition will be held at Dr. Karni Singh Shooting Ranges, Tughlakabad, New Delhi from 25th June to 27th June 2025. Those who are interested in participating in this competition should comply with the following guidelines:

#### Eligibility:

1. As per norms of NRAI, all Delhi domicile school students above 10 years of age, who have registered themselves as shooters of Delhi and applied for NRAI Shooter ID under DELHI are eligible to participate in this competition. Strict Covid protocols as per government guidelines will be followed.
2. Shooters belonging to Delhi who are studying in schools outside Delhi can also participate in this competition. Shooters belonging to other states who are studying in schools located in Delhi are not permitted to participate in this competition as they will need to participate in the Inter-School Shooting Competition organized by their home state.
3. The scores achieved during this competition in National Rules (NR) Category matches will only be considered as Minimum Qualifying Score (MQS) for participation in the next All India Inter-School Shooting Championship. The ISSF Matches are only for the shooters who have participated in any ISSF category matches in past, therefore new shooters or those who have not qualified for participating in ISSF category matches should participate in NR category matches only.
4. The entry of this competition can only be submitted ONLINE on NRAI Website [www.thenrai.org](http://www.thenrai.org)
5. The time, date and the detail in which a shooter will shoot his /her match will be pre-

allotted and the details of the same will be shared prior to the matches on DSRA website [www.dsra.in](http://www.dsra.in).

6. Those shooters who do not have NRAI Shooter ID Card, need to apply for NRAI Shooter ID on NRAI website [www.thenrai.org](http://www.thenrai.org) and register themselves with NRAI by uploading their Photograph, MCD Birth certificate, Passport, Adhaar Card etc. after which, the provisional NRAI Shooter ID Card Number will be generated instantly which can be used for submission of Inter-School entry on NRAI website.
7. The entry form should be printed, signed and physically stamped by the school authority. It should then be scanned and uploaded. The original of the said Entry Form duly signed and stamped by the school has to be shown on the day of the competition.
8. Proof of age and address should be carried in ORIGINAL on the date of competition.
9. Shooters will be allowed to participate under age categories match as shown under  
JUNIOR - born in year 2006 or after  
YOUTH - born in year 2007 or after  
SUB YOUTH - born in year 2010 or after
10. It is clarified that a shooter can participate only in one age category. So a sub Youth category shooter has the option of participating in Sub Youth or Youth or Junior, while Youth category shooter can participate either in Youth category or Junior category and a Junior category shooter can participate only in Junior category match.
11. International Air Rifle / Air Pistol Shooters are not permitted to participate in this competition.
12. A shooter can participate in ISSF category match only if he/ she has participated in any ISSF category matches in the past or if he / she is qualified to participate in ISSF category matches.
13. Shooters who have already participated in any ISSF category matches organized by DSRA or NRAI are not permitted to participate in NR matches of this competition. If any shooter who has already participated in any ISSF category match in past participates in a NR category match of this competition then he / she will be disqualified and appropriate disciplinary action will be taken.
14. There will be no team events in this competition.
15. Protest Fee is Rs. 500/- and protest can be within first 30 minutes of declaration of tentative results.  
Charges for correction of wrong entries is Rs. 200/- + 18% GST (Total = Rs. 236/-)
16. The "Date" and "Time" for Prize Distribution ceremony will be announced later on.
17. The last date for submission of entries is 17<sup>th</sup> June 2025 till 11:59 pm, after which entry will be accepted on payment of triple entry fee till 19<sup>th</sup> June 2025 till 11:59 pm.

19. In case of postponement of competition, the Entry fee will not be refunded, but instead will be adjusted in future competitions.
20. Delhi State Rifle Association reserves the right to alter any condition of this competition to ensure smooth conduct of this competition. In case of any protest, the decision of the organizing committee will be final.
